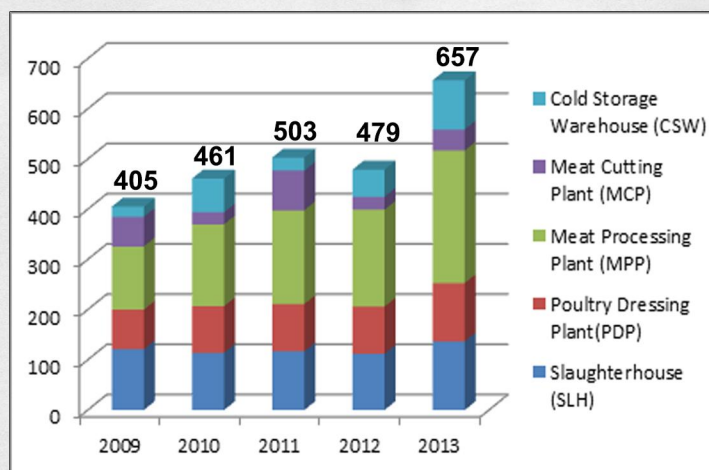
For NMIS, 2013 was a banner year. The NMIS supported the Department of Agriculture in successfully advocating for the passage of two laws which strengthens government regulatory functions. These laws enacted by the Congress of the Philippines are:

1. Republic Act No. 10536 which amended RA 9296 or the Meat Inspection Code of the Philippines as Amended.
2. Republic Act No. 10611 otherwise known as The Food Safety Act.

Accreditation, Registration and Enforcement Division

Accreditation of Meat Establishments

The NMIS accredits meat establishments (MEs) such as slaughterhouses, poultry dressing plants, meat processing plants, meat cutting facilities and cold storages for meat after making sure these MEs are in conformity with the minimum requirements needed by standard evaluation criteria. The accreditation also extends to ME contractors, fabricators, suppliers and meat delivery vans/transport.

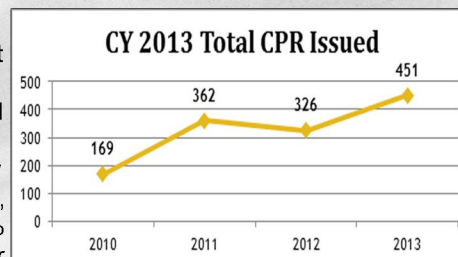


The number of accredited MEs increased by 18.56% in 2013 from 555 MEs to 658 MEs. The 264 MPPs accounted for 40% of the total accredited MEs, the 137 SLHs, 114 PDPs, 43 MCPs and 98 CSWs comprised 21%, 18%, 6% and 15%, respectively, of the total.

Registration of Products.

The Departments of Agriculture (DA) and Health (DOH) Joint Administrative Order (JAO) No. 1 series of 2009 encourages ME operators and owners to register their products.

The NMIS issued 451 Certificates of Product Registration (CPRs) in 2013. Of the total CPR, 231 certificates were issued to locally manufactured products, the rest, Some 38.36% or 173 CPRs were for imported manufactured products.

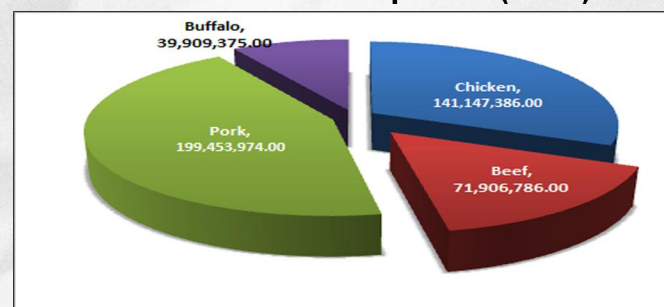


Meat Import Export Assistance and Inspection Division

Import

A total of 452,417,522 kg of imported meat and meat products were monitored and inspected of which the highest proportion was pork (44%) and chicken (31%) followed by beef (16%) and buffalo (9%)

Export

Exporting companies continue to market their meat and meat products internationally to different country destinations such as Japan, South Korea, and Brunei.

A total 288 Official Meat Inspection Certificates were issued covering 7,173,978.79 kg meat and meat products inspected and certified for export in

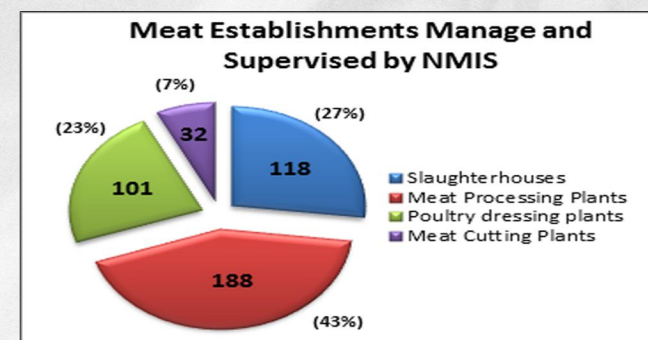

Plant Operation and Inspection Division

Meat Establishments Supervised

The NMIS provides in-house meat inspectors and meat control officers for "AA" (national market) and "AAA" (domestic and international markets) facilities. These meat establishments (ME) are subject to compliance to Good Manufacturing Practices (GMP) and Sanitation Standard Operating Procedures (SSOP). For "AAA" MEs, the NMIS regularly conducts Hazard Analysis and Critical Control Point (HACCP) audit for meat products.



For 2013, a total of 429 meat establishments were directly supervised by the NMIS under the POIS. Of this total, 188 MEs or 43% were Meat Processing Plants (MPP), 118 MEs or 27% were slaughterhouses (SLH), 101 MEs were poultry dressing plants (PDP) or 23% and 32 MEs or 7% were meat cutting plants.

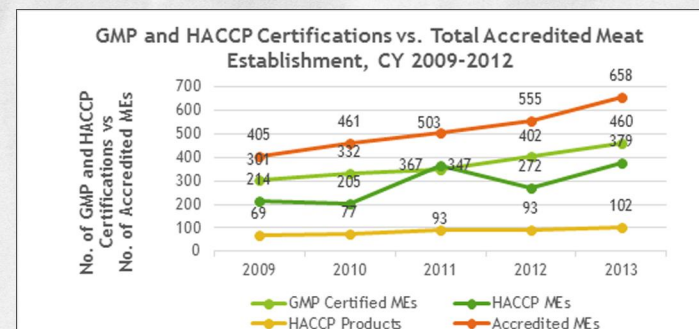

The 439 accredited meat establishments in 2013 slaughtered 483,487,638 heads of various animals generating a total dressed weight volume of 793,456,254.60 kilograms

Meat Safety Assurance Program

In 2013, 599 accredited MEs applied for but only 457 MEs or 76.29% were certified for GMP/GOP. This is an increase of 13.68% from last years' total of 402 GMP certified meat establishments. The said certified GMP MEs were 186 (40%) MPPs, followed by 86 (18%) PDPs, 86 CSWs, 72 (15%) SLH and 27 (5%) MCPs.

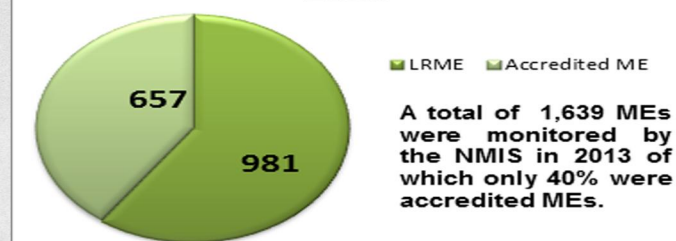


Over the same period, the 110 HACCP accredited MEs had 379 meat products certified. This represented an increase of 19% from the 93 MEs and 39.33% increase from the 272 certified meat products recorded in 2012.

Meat Science and Technology Division

This is a support program of the agency linking with the Local Government Unit (LGU) counterparts for their capability building and development. The program equips technical personnel, both local (LGU) and national (NMIS), with valuable expertise needed in the performance of their profession and in the rendering of their services to stakeholders.

A total of 7 BMITC were completed this year with 136 graduates from different regions.

Laboratory Services Division

This is one of the support programs to the regulatory functions of the agency through a variety of activities such as testing/analysis and monitoring of swab, water, meat and meat products samples. Its subprograms are the National Veterinary Drug Residue Monitoring Program (NVDRMP), the Trichinella Monitoring Program and the Pathogen Monitoring Program (PMP). The program has 7 functional laboratories, 6 regional satellite laboratories and the central laboratory.

In 2013, the NMIS laboratories conducted 22,390 tests distributed as follows, 16,639 for Pathogen Monitoring, 8,868 for the National Veterinary Drug Residue Testing which includes Microbial Inhibition Test (MIT) for 6 drug-families and Enzyme Link Immunosorbent Assay (ELISA) for 5 drugs.
